

TRAVELLER DETAILS

1. Passport requires physical
 - Passport should be valid for at least 6 months from the date of return and should have at least 2 blank pages.
 - Enclose any old passports with the application.
 - Handwritten passports, passports with observations mentioned and passports valid for more than 10 years are not accepted.
2. Vaccination Certificate
 - A photocopy of the vaccination certificate indicating completion of both doses is essential.
3. Photographs requires physical
 - Photograph requirements: Dimensions of 35mm x 45mm, clicked within the past three months, featuring 80% of the face, captured against a plain white background with a matte finish.

MANDATORY DETAILS

1. Visa Application Form
 - The form should be duly filled & checked by the applicant.
2. Appointment Confirmation
 - Appointment Confirmation Letter.

ADDITIONAL REQUIREMENTS

1. Covering Letter
 - Stating the applicant's purpose of visit and personal details addressed to the Embassy of China, Delhi Or Consulate General of China, Mumbai Or Consulate General of China, Kolkata.
2. Specific Mandates
 - All documents must be in English else official translation is required for documents in other languages. The Embassy or Consulate may request additional documents or a personal interview on a case-by-case basis.
 - Biometrics are mandatory.

OCCUPATIONAL DETAILS

1. Self-employed
 - Cover Letter on official business letterhead.
 - Business Registration Certificate, such as GST certificate, Certificate of Incorporation, Partnership Deed, MOA, etc.
 - Valid proof of proprietorship.
2. Employed
 - Provide the following company letters on official letterhead, including the applicant's name, designation, and signature of the authorized signatory:
 - Payslips of last 3 months.
 - Company Appointment Letter (if the applicant has recently switched the company).

CONDITIONAL REQUIREMENTS

1. Stay proof
 - Rental agreement (or) Original company letter is applicable, if the passport is issued in a different jurisdiction from the jurisdiction of visa application.
 - Mumbai jurisdiction: Maharashtra, Karnataka.
 - Kolkata jurisdiction: Orissa, West Bengal, Chhattisgarh, Jharkhand, Bihar.
 - Delhi jurisdiction: All other states.

BUSINESS DETAILS

1. Overseas company details
 - Company registration certificate of inviting company.
2. Host details
 - Inviting person's valid ID.
3. Invitation letter
 - An invitation from the Chinese company must adhere strictly to the Embassy's specified format (Invitation letter format attached in the Forms section).
 - Signatory Name should be written in the Chinese language.
 - Signatures should be cross signature on company seal (and should be in Chinese).

KINDLY CONSIDER THE FOLLOWING INFORMATION AS IMPORTANT BEFORE APPLYING FOR VISA:

- Visa fees & Service Charge are non refundable against any refusal or cancellation.
- Visa grant or refusal is at the sole discretion of the embassy.
- Visa processing time is decided by the Foreign Missions.
